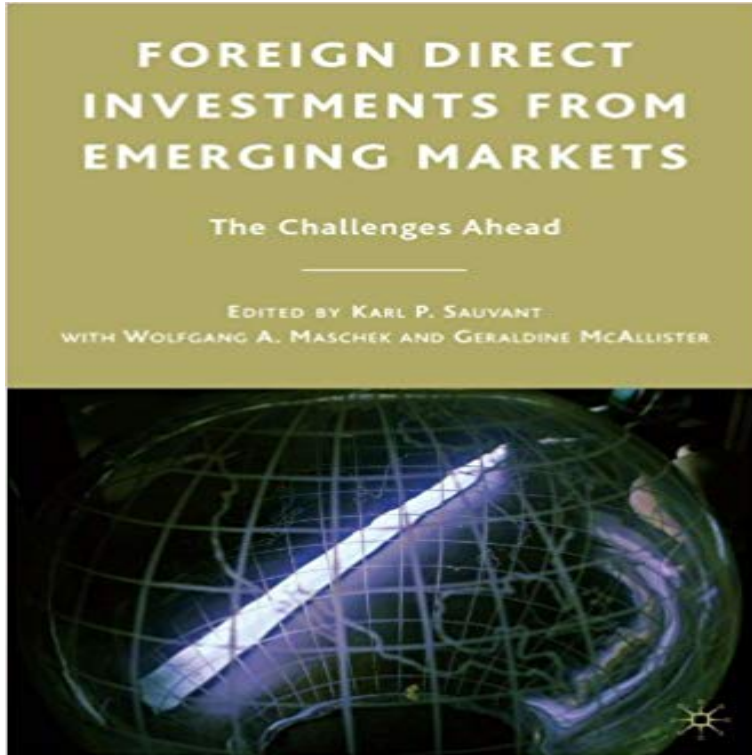


Foreign Direct Investments from Emerging Markets: The Challenges Ahead
