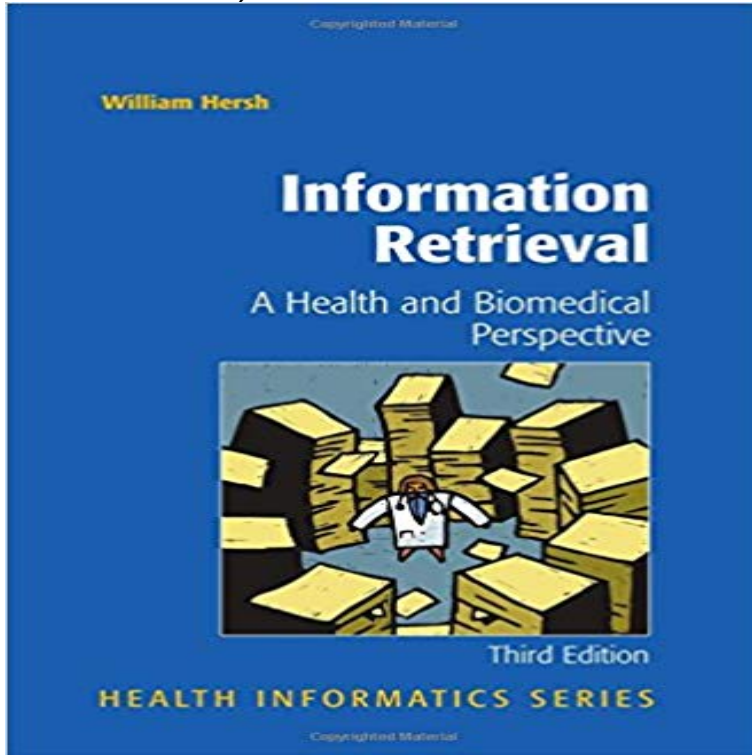


Information Retrieval: A Health and Biomedical Perspective (Health Informatics)
